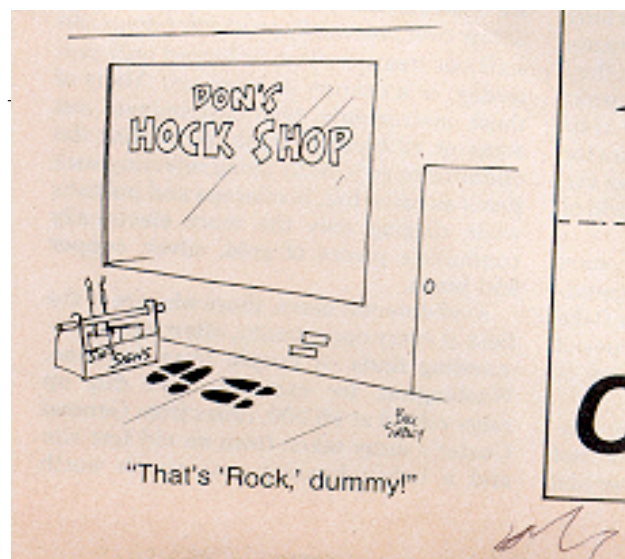

BLM - DESERT NEWS

The Eastern and Northern Colorado Desert Plan (NECO), a part of the Regional Habitat Conservation Plan is still being studied and revised. The public hearings for comments on the plan were held this summer. Three BLM personnel were available at the CFMS Show and Convention in Ventura in 1997 to provide information about this plan and to seek rockhounds input. Dick Crowe, the project leader spoke at the Ventura Convention and at the CFMS - South meeting in April, 1998. He showed the maps and discussed the plan, answered questions, and sought input from those in attendance. At the CFMS Show meeting this year, Jim Strain and I reported the progress of this plan and received the backing of the CFMS Board of Directors to try to establish a Rockhound Park in the Houser Geode Area. Ed Hasty, the BLM California State Director, encouraged us to pursue our plan. We felt that this historical collecting area was worthy of being set aside, not to prevent collecting but to assure its preservation for rockhound use.

I was sorry to hear that a letter that was circulated which had contained some incorrect information was exciting some of our members. I have studied the proposed three plans of NECO and do not find the statement, *All of the Eastern desert in Imperial County would be closed, except for a two mile strip along the Colorado River.* It does not list the closure of all routes. It does recommend the closure of some washes in areas where travel seems to be harmful to some species on the endangered list. The BLM learned a lesson from the desert bill restricting the access to the guzzles built for the big horn sheep, etc. "No off road travel" is a part of the plan, but I think people do not need to drive to the collecting spot. What happened to the fun of walking and looking for new rocks and minerals? I have not found a reference to the recreation mineral collecting in the document.

There are two more plans that are a part of the Federal and California Endangered Species Acts that are being presented - the Northern and Eastern Mojave Plan (NEMO) and the Western Mojave Plan. It seems that most rock collectors' feel using logic and reason are better than ranting and raving. More rockhounds need to take an interest in the information about these plans that is presented at the Public Hearings and/or read the plans. Jim Strain, Sue Hickman and many others, as well as I have volunteered much time and given much thought to these. As the new plans are made available, please read them thoroughly and if you do have questions or concerns, make them known. Please do not base your reactions on "half of the story".

The rules that govern the use of the desert are made in Washington, DC and the State Offices of California. The leaders do not always feel the same as we do about educational and recreational use of the desert. **Be sure to vote in November!**

ALAA REPORT ON THE 105TH CONGRESS

The ALAA monitors the activities of the Federal Government, including the President, the public land managers, and the U.S. Congress. Our interest is for initiatives and actions that affect or could affect hobby activities on public lands. A summary of the public land bills passed in the 105th Congress along with a comparison of the two previous Congresses shows that this Congress was less interested in public land matters. We would observe perhaps ‘less’ is better, depending on the subject and on your perspective. Consider the following comparison of activities of the previous three Congresses:

Our observations are that the 105th Congress was a “good” Congress in terms of avoiding further restriction of access to public lands for hobby pursuits. In the 105th Congress, the major Bill passed that effected public land was the expansion of the Eagles Nest Wilderness in the Arapaho National

Forrest and the White River National Forest in Colorado which added 160 acres to wilderness. The other Bills were primarily minor land exchanges and transfers.
