# Stone for Month of October is Opal

The name is derived from an Indian word for "Stone. It is divided into three groups. The opalescent precious opals, the yellow-red fire opals and the common opals. Their physical properties vary considerably. The color can be white gray, blue, green, orange. Mohs' hardness varies from 5 to 6 1/2.

**Precious Opal**: The special characteristic is its opalescence, a rainbowlile iridescence which changes with the angle of observation due to refelction and interference effects of very small spheres of the mineral cristobalite embedded in a silicious jelly cement. When water content is reduced the opalescence lessens and the stone may crack. Store stones in damp cotton wool.

**Fire Opal - Orange-Red**: Shows no opalescence and is usually milky and turbid. The best qualities are clear and transparent. They are very sensitive to stress. Important deposits are in Mexico; also Brazil, Australia.

Common Opal: Mostly opaque, without play of color, it is quite common. Many names are used for it in trade such as: agate opal (agate with amorphous opal layers), hyalite, wood opal, honey opal, milk opal, mother of pearl opal, prase opal formerly called chrysopal & if dendrites are included, moss opal.

Opals are thought to be bad luck to wear unless they are your birthstone. One story is, during the Black Death in the 14<sup>th</sup> Century the people of Venice, Italy, noticed that opals became brilliant when a wearer caught the disease and dulled when the person died. Another story claims that in the 17 Century court of the French King, his coaches were named after gemstones. The driver of Opal was usually drunk and the coach was considered unlucky. In the Orient, Opal stands for loyalty and hope. Opal is gorgeous and beautiful, so it all depends what you want to believe.

An interesting fact about Australia is that the opal localities are very hot, so when mines are exhausted those excavations near the surface are adapted to provide relatively cool living conditions. We believe that Joan and Walt Abramson lived in some of these homes during their hunting for opal in Australia.

# NOC Board Meeting Minutes La Habra Community Center September 11, 2007 at 6:00 PM

The meeting was opened by President Don Eschbach at 6:00 P.M. at the Community Center.

**Attended by:** Don Eschbach, Richard Shirer, Don & Ofelia Warthen, Don & Loretta Ogden, Bill & Izzy burns, Jay & Kathy Valle, Nancy Bird and Mike Beaumont.

#### 1. Vote to Amend the Articles of Incorporation

Don Eschbach began the meeting with a discussion of the proposed changes to the Articles of Incorporation which would bring us more closely in line with the 501(c)(3) incorporation change that NOC is seeking.

Ofelia Warthen asked that the list of changes be read and Don Eschbach read the following to the Board:

Article II, Paragraph B, reads as follows: "The specific purpose of this corporation is to enjoy and promote interest in the lapidary arts and related fields." The articles of the incorporation of the corporation is amended to read as follows: "The specific purpose of this corporation is to promote, study and educate the youth, seniors and the community in general, in the sciences of mineralogy, geology, lapidary arts and other earth sciences."

Article V reads as follows: "The property of this corporation is irrevocably dedicated to charitable purposes and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer or member thereof or to the benefit of any private person. Upon the dissolution or winding up of the corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed to a nonprofit fund, foundation or corporation which is organized and operated exclusively for charitable purposes and which has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code." The articles of the incorporation of the

corporation is amended to read as follows: "The property of this corporation is irrevocably dedicated to charitable, scientific and educational purposes and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer or member thereof or to the benefit of any private person. Upon the dissolution or winding up of the corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed to a nonprofit fund, foundation or corporation which is organized and operated exclusively for charitable purposes and which has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code."

(Don Eschbach continued) When we submit the application to change from a 501(c)(4) to a 501(c)(3) we must emphasize education. Also, the name of the person on the Articles of Incorporation must be the same as the name of the person on the Application. The person whose name is on our current Articles is long deceased.

**Motion:** Izzy Burns made the Motion that we accept the changes to the Articles of Incorporation as read. The Motion was seconded by Richard Shirer.

**Discussion:** This change would also allow us to seek Grants and Donations needed for the proposed workshop, and other projects.

**Vote:** The Motion carried unanimously.

#### 2. Equipment Donated

Several pieces of lapidary equipment were donated to NOC for use in our proposed workshop, including an 18" slab saw in excellent condition, several grinders and polishing units with motors (silicon carbide type), 2 - 10" trim saws, 2 flat laps, a burnout oven (220V) and a tumbler with several barrels.

Currently, they are being stored in a side yard outside at Don & Kathy Eschbach's house. Jay Valle and Don Reese suggested that several plastic trash cans with sealable lids be purchased to store and protect the equipment for the weather. Don Eschbach requested that the Board authorize him to purchase 4 trash cans for this use.

Richard Shirer made a **Motion** that we authorize Don Eschbach to purchase 4 plastic trash cans with lids to store the equipment and Frank Winn seconded the Motion. The **vote** was unanimous in favor of the Motion and the Motion carried.

#### 3. Communication on Field Trips

Don Eschbach opened a discussion of whether the Club should purchase some 2-way radios for use on field trips.

Discussion: CBs have been the communication device of choice in the past but the small hand-held FM radios have gained in popularity because of their low cost and ease of use.

Hand-held FM transceivers have several drawbacks - they do not put out a lot of volume and can be difficult to hear when off the pavement; they have tendency to distort voices and can be hard to understand (different brands of radio may be better than others); they need to be higher distance types as the 2 mile range units, for example, may not reach car-to-car over as little as a 1/4 mile when caravanning. They are primarily "open air" and line of sight devices. The metal of the car degrades the signal between vehicles.

CBs are more rugged, the antenna is mounted outside the car, either permanently installed or a temporary magnet mount type, so the signal does not have to go through the car body to reach another radio. Hand held units work ok, though some have problems with distortion when the volumes are turned high (off road/noisy car). Permanently installed CBs with associated antenna are reliable and effective but have a higher initial cost and many vehicles lack a place to mount them.

No decision was reached regarding if the Club should purchase radios or CBs. Don Eschbach directed Jay Valle to research these two types of car-to-car communication to see what the relative merits of each are, and to make a recommendation as to which he, as Field Trip Chairman, prefers.

#### 4. Other Business

- Don Warthen reminded us that we would be voting on the Bylaws changes in the Regular Meeting, later tonight.
- There was a clarification of the Board position of Federation Director: the job of Federation Director is defined by NOC Bylaws, not by the CFMS.

For October, we have been invited to join the Monterey Park Club at the Bowers Museum to see the Michael Scott Collection.

The Michael Scott Collection is the most important private gem collection in the United States, with few rivals in the world outside of the royal families; the Michael Scott Collection is back at Bowers Museum and features even more luxurious pieces. *GEMS! Colors of Light and Stone*.

GEMS! Colors of Light and Stone is the most important exhibition of colored gemstones, diamonds and gems as art ever shown in a U.S. museum." says Dr. Peter Keller, president of Bowers Museum, who is also a geologist and gemologist and who curates this exhibit.

In *GEMS! Colors of Light and Stone* you'll see most of the major gem species in every color and variety known.
