October Birthstone: Opal

The October's birthstone is opal. It treats the eye to an explosion of shimmering colors, not unlike those of a magnificent rainbow following a summer rain. The Opal derives its name from the Latin word "opalus," meaning precious jewel.

Prized for its unique ability to refract and reflect specific wavelengths of light, the Opal was called "Cupid Paederos" by the Romans, meaning a child beautiful as love. One legendary explanation for this gemstone's origin is that it fell from heaven in a flash of fiery lightning.

Ancient monarchs treasured Opals, both for their beauty and for their presumed protective powers. They were set into crowns and worn in necklaces to ward off evil and to protect the eyesight. These gemstones were also ground and ingested for their healing properties and to ward off nightmares.

The Opal dates back to prehistoric times. It is a non-crystallized silica, which is a mineral found near the earth's surface in areas where ancient geothermal hot springs once existed. As the hot springs dried up, layers of the silica, combined with water, were deposited into the cracks and cavities of the bedrock, forming Opal. This gemstone actually contains up to 30% water, so it must be protected from heat or harsh chemicals, both of which will cause drying and may lead to cracking and loss of iridescence. Opal must also be guarded from blows, since it is relatively soft and breaks

Most of the world's Opal deposits are found in Southern Australia. Other sources of this gemstone are Brazil, Mexico, Czechoslovakia, and Nevada. Quality Opal is very expensive, made more so by the caution that must be exercised in cutting, polishing and setting it into jewelry.

A gift of Opal is symbolic of faithfulness and confidence. And the powerful energy radiating from this fiery gemstone will surely illuminate any occasion!

Bylaws: Don Warthen read the text of 3 changes to the bylaws recommended by the Bylaws Committee and approved by the NOC Board. The changes are:

- 2. The new officer nominations to begin in June instead of September, with the election of officers to occur in October rather than November.
- 3. This change requires that a budget committee be formed in October to start planning for the following year's budget.

Recommended that the following changes County Gem & Mineral Society Bylaws:

ARTICLE IV INITIATION FEES AND DUES

SECTION I DUES AND FEES

- A. Individual Membership dues shall be \$20.00 per year and a one time initiation fee of \$10.00 per person will be assessed each new member.
- B. Family Membership: the first persons dues shall be \$20.00 per year and \$10.00 per year for each additional person over the age of 18. A one time initiation fee of \$10.00 per person will be assessed each new member. (Family means one unit living in the same household)
- C. Junior Membership for family members from 3 through 18 years of age shall be \$8.00 per year. Badges for junior members are available for a one-time fee of \$10.00.
- D. New members joining the club on or after June 1st shall pay a proration of six months dues the first year i.e. Individual and the first family member shall pay \$10.00 each additional person shall pay \$5.00. Junior Members shall pay \$4.00 per year.
- E. Public liability insurance fees are included in membership dues.
- F. Honorary membership, conferred as an honor.
- G Annual dues are payable January 1st of each year.

Recommended that the following changes County Gem & Mineral Society Bylaws

ARTICLE VIII COMMITTEES

(New) SECTION 2 BUDGET

- A. Following the October meeting, The President shall appoint a Budget Committee consisting of the Treasurer, who will be acting as Committee Chairperson and Two to Four other Society members in good standing to the Budget Committee.
- B. The show chairperson, education chairperson, and other interested chairpersons shall present proposals for the budget to the budget committee on or before the December General Meeting.
- C. The Budget Committee shall meet and draft a budget to be presented at the January General Meeting for approval.

SECTION 3 THE OLD SECTION 2 WILL BECOME SECTION 3.

ARTICLE V OFFICERS

SECTION 2

NOMINATIONS

- A. A nominating committee consisting of five (5) members shall be selected at the *June* meeting in the following manner; the President shall appoint one (1), the Board of Directors will elect one (1), and the Society shall elect three (3).
- B. It shall be the duty of the nominating committee to nominate one or more members in good standing as candidates for each of the offices to be filled. The names of all candidates nominated by this committee shall be presented to the membership in the *September* bulletin prior to the *September* meeting.
- C. Further nominations for office by the membership from the floor shall be allowed at the *September* meeting.
- D. A complete list of all names nominated by the committee and those nominated by the membership from the floor at the *September* meeting, as candidates for office shall be published in the *October* bulletin prior to the *October* meeting and election. No further nominations shall be allowed at this time.

SECTION 3

ELECTIONS

Election of officers shall be held on the first regular meeting in *October*. Voting shall be by secret ballot. The candidate receiving the greatest number of votes cast on the ballot for that office shall be declared elected. Voting shall be restricted to members 18 years of age and older in good standing.

SECTION 4

TERM OF OFFICE

Officers and Directors shall serve for a term of two (2) years from the date of installation, the second Tuesday of December following the election, except the Federation Director, which shall serve for a three-year (3) term.
